Shadow Woods Roads

We reported in an earlier newsletter that the city of Rochester Hills was planning on rebuilding the streets in our subdivision in 2008. The plan now is to start the rebuild in April of 2005 with completion in November. The work will be extensive including new roads, curbs and edge drains. Ten feet of our front yards and the first section of our driveways may be replaced. Brick mailboxes will be torn down and replaced with wood ones by the city. All other mailboxes will have to be replaced by the homeowner. It will be everyone's responsibility to pull up their sprinkler systems and replace. There is a possibility that Powderhorn Ridge will be rebuilt earlier. As of now the funding for this is not approved. We will know for sure in November 2004. Letter from the President

Dear Residents.

It seems that we have been in the midst of a building boom in our corner of Rochester Hills for the last year. Most of us with school-age children experienced school construction last year, and it's not quite finished yet. Next, we were all greeted with the mall construction and road repaving north, south, east and west. And off of Brewster, we'll have a brand-new subdivision as neighbors.

I'm sure most everyone has visited our new mall by now, and it really is similar to a small village--people, cars, bikes and skateboards in every direction. And if you have the chance, check out Manchester Knolls to our east off Brewster.

All of this development makes me believe that our little enclave can be all the more desirable in this era of new homes in our area that start at \$500,000. Our real estate is going to look all the more attractive--especially if homeowners take care of their property. That makes it all the more important for each one of us to follow the deed restrictions and by-laws that are posted on www.shadowwoods.com. Every resident is responsible for following these restrictions and by-laws.

As a reminder, these are the most common infractions of our deed restrictions:

Section 9. a. No lot shall be used or maintained as a dumping ground for rubbish, trash, garbage or other waste, and the same shall not be kept except in sanitary containers properly concealed from public view. Garbage containers shall not be left at the road for more than 24 hours in any one week.

Section 9. b. <u>No house trailers, commercial vehicles, boat trailers, boats, camping vehicles or camping trailers may be parked on or stored on any lot in The Subdivision, unless stored full enclosed within an attached garage.</u>

Section 13. a. <u>No fence</u>, wall or solid hedge may be erected, grown or maintained in front of or along the front building line of any lot. b. No fence or wall may be erected or maintained on or along the side lines of any lot, and/or on or along the rear line of any lot, except fences which are required by local ordinance to enclose swimming pools.

If we all abide by the rules, we all benefit.
