## Maintenance Committee News-Dave Reese, Maintenance

As a cost saving measure, in 2004 we entered a three year agreement with United Lawnscape, Inc. of Shelby Township. This contract gave us the same rate for 2004 that we had the previous year. We had a 3% increase in 2005 but this rate remains the same for 2006. The contracted services include mowing, trimming, edging, fertilization and weed/crab grass control of grassy areas. They also provide for trimming, feeding, insect control and pruning of trees and shrub areas. We have contracted with MCA Landscaping, the company that plants and maintains the flowers at our entrances, for weed control and weed removal in all mulched common areas to maintain an attractive appearance, Due to the dry conditions during the late summer and fall, lawn cutting for some weeks was unnecessary and therefore skipped.

We had to have some major tree trimming work done recently to the willow trees in our commons areas and to a large tree that fell and blocked the nature path in our woods. We also had to have a dead Ash tree and its stump removed.

We had favorable comments from residents regarding our holiday lighting last year. We will be contracting with the same company again this year for the holiday lighting at our entrances

Don't forget to turn on your holiday lights for the decorating contest taking place **Sunday, December II at 6 PM.** All homes are entered in the contest. You do not need to be home during judging. Judges are non-Shadow Woods residents. Judging will be based on creativity, color, eye appeal and use of theme.

# Letter From the President

#### Dear Residents,

As a result of the failure of the road millage passing in last November's election, several Shadow Woods residents attended the annual meeting to voice their concern and see what could be done. That was the beginning of a citizen's committee called ROAR—Repair Our Aging Roads.

This committee has roots in Shadow Woods but worked closely with residents throughout the city and with city hall to come up with a better millage proposal for November 8, 2005. This 10-year millage begins at 1.5 mills and increases slightly each year by .33 mills for five years until it reaches a maximum of 2.75 mills. This is less than what was requested in the last election. It is a 10-year millage dedicated to local roads and will also restore snow plowing to previous levels.

No one wants to pay more taxes, and indeed, Rochester Hills has the third lowest tax rate in Oakland County. Our City Charter was written with a small General Fund tax, only 3.1 mills, and does not provide the city with enough revenue to reconstruct our aging roads. Nowhere is this more apparent than in Shadow Woods. Our roads are not only detrimental to our property values they are a safety hazard. Therefore, it is in our best interest to vote yes on the November 8 millage for roads and urge other homeowners throughout the city to do the same. After all, who's to say their roads won't look like ours in five years? And don't forget, if our roads get bad enough, the city can legally make us a Special Assessment District, or SAD, which would require homeowners to pay the full amount of the reconstruction. It seems much more fair to spread the cost over the entire city. If you'd like more information, please email supportroads@aol. com.
