2003 Annual Assessment Invoices

The 2003 SWSA annual dues invoices were mailed March 1, 2003. This invoice for \$114.00 will be due on or before April 30, 2003. Membership in the Association is mandatory. No property owner is exempt.

As printed in the Shadow Woods 2002 Annual Report To Membership dated October 8, 2002, "The Board has approved a 2003 dues assessment of \$114.00. This assessment will allow us to afford ongoing general operations. The Association By-Laws provide that the Board of Directors may increase dues by 5% from the level authorized for the previous year. The Board has approved such an increase in authorized (maximum) due from \$109 to \$114 for 2003."

Lien Activity

The SWSA filed six liens in the Oakland County court system against property owners who failed to pay their 2002 annual dues. Besides owing the \$109.00 assessment, filing fees of \$18 were added. Interest is accruing as of 5/01/2002. Per SWSA By-Laws, all monies must be paid in order to discharge the lien.

As of 3/17/2003, total lien amount outstanding from 1989 thru 2002 is \$2,892.36.

Hazardous Waste

Rochester-area residents will finally have a safe and reliable drop-off spot for their hazardous waste this summer. The North Oakland County Household Hazardous Waste Inter-local Program will schedule 12 collections this year with a one-way travel time by car expected to be 30 minutes or less for most residents. The first collection is scheduled for May 3.

The collection sites will accept almost any type of household waste, including oil-based paints, photo chemicals, batteries and aerosol cans. Medical waste, asbestos, explosives or radioactive devices such as fire alarms will not be accepted.

Residents will need to call ahead and make an appointment before visiting a collection site. The county will provide a reservation phone number along with a Web site to gather more information sometime in the next few weeks.

Entrance Improvements Planned

We are planning on upgrading the two Powderhorn Ridge entrances at Adams and Brewster. The plans are in the design stage now. We will be keeping some things and replacing others. We will remove the mugo pines and overgrown shrubs on the large island on Powderhorn near Adams, leaving the large pines. The work will be done early this spring.
