#### Grounds Maintenance

The SWSA board has renewed the contract with United Landscape of Shelby Township to provide all of our grounds maintenance. United Landscape is offering Shadow Woods residents a discounted rate for individual lawn maintenance of \$23 per cut to each resident. This service includes weekly lawn maintenance using residential size walk behind lawn mowers (better than in previous years), trimming, edging of walks and drives, and removal of clippings from walkways.

Their fertilization programs offer granular applications which include a spring pre-emergent green-up, summer weed and feed, summer slow-release, fall feeding, and spot applications of liquid weed control as needed. The 6 application program is offered at the **reduced price of \$32.00 per application**. If you are interested in either of these programs, contact United Landscape at 586-739-5296 and be sure to mention that you are a Shadow Woods resident.

Dear Residents and Citizens,

Spring is in the air and the usual armada of True Green and Chemlawn trucks are bound to be shortly on its heels. We are a compassionate, intelligent, and informed community that has the ability, luxury, and duty to affect our surroundings in positive not negative ways. As humans and citizens I beg you to strongly consider the impact of inorganic fertilizers, pesticides and lawn "care" products on our surroundings, families, and general well-being, and to reconsider your use of these products.

Ask yourself some simple questions:

If your water were drawn from a well in your backyard would you still use chemicals on your yard?

Is it ethical to deliberately release non-beneficial and in many cases truly toxic chemicals into the environment? Furthermore, is it ethical to do this for a greener lawn?

How much of your lawn care practices are aimed at keeping up with the Jones's?

Why do you think that the company is called CHEM-lawn?

These are simple but fundamental questions that many have either failed to address, or have been afraid to tackle for fear of being the only one with a not-so-emerald green lawn.

I understand that intensive lawn cutting regimens can sap the life from grass and make "necessary" the use of additives and pesticides, but think of what you are really doing. In many cases you may be investing time and money in mowing your lawn that ultimately forces you to spend even more time and money controlling the damage done. Consider cutting your lawn to a slightly higher length, thus mitigating the need for unnecessary chemicals.

You can benefit all of our lives and save a bunch of money by using a mulching mower mulching mower blade, and/or turning your copious kitchen and lawn scraps into a safer, more balanced, and more effective fertilizer by composting. Composting for lawns of our size requires only a 3 foot cube and a very small investment of time and energy. Thank you in advance for your anticipated support!
