# Village Of Rochester Hills Construction Underway

Construction began in July on an open-air shopping center whose central walkway will be a tree-lined boulevard named Main Street. The location is the former MeadowBrook Village Mall which anchors the southwest corner of Shadow Woods subdivision.

Retail chains including Ann Taylor, J. Crew, Chico's and Farmer Jack have snapped up leases for store facades meant to evoke the feel of an old-time downtown, set to open in fall 2002.

A five year legal battle between the operators of Meadowbrook Village Mall and the City of Rochester Hills ended last November, paving the way for the project. Since then, city officials have thrown their weight behind the project that "will be the downtown that Rochester Hills never had," said Mark Winter, a spokesman for operators of MeadowBrook Village.

The center's 32-acre footprint - less than half as big as Oakland Mall in Troy and barely a third that of Great Lakes Crossing mall in Auburn Hills - is large enough to lure major retailers but not so massive that it will tie up traffic on adjoining Walton Boulevard and Adams Road, said. Jim Fielder, Vice President of Acquisitions for Robert B. Aikens & Associates , the builder.

The Homeowner's board has already expressed concern about increased cut-through traffic on Powderhorn Ridge, and is working on getting assistance from the City of Rochester Hills to address this issue.

### Spring Subdivision Clean-up

The Shadow Woods Subdivision Spring cleanup was held on Saturday, April 28th. The event was an overwhelming success thanks to the many residents that eagerly participated. #### Sign Improvement

You may remember that we were considering the purchase of new entrance signs for Shadow Woods. After our last board meeting, we decided to look into

the repair and maintenance of our existing signs for several reasons.

First of all, the new city restrictions on signage meant that new signs would have to smaller than our existing signs. The new restrictions also meant that we would have had to place the sign for the Adams entrance on the island, and that the entrances at Telluride and Hidden Valley would not have a sign at all. Plus, new signage would have required a special assessment vote and meant additional money from our residents if the vote had passed.

For these reasons, the board felt that it was prudent to maintain our current signs. The rotted wood will be replaced as necessary, knot holes and cracks will be caulked and the signs will be painted. The new color scheme should make the signs stand out at their locations much better. The work should be done shortly.
