## Letter From the President

Dear Residents,

As we prepare to say hello to summer, we all look forward to outdoor activities and yard work. I look forward to cleaning up my yard and sprucing things up. I hope you will join me in making our neighborhood look "clean and green".

The Shadow Woods Capital Improvements committee has been working with the city on expanding the new roadside trees along Tienken. Maybe you have seen the brand new saplings recently planted along both Tienken and Brewster Roads. The goal is to give a "wooded lane" look to our part of the world. Because we are leveraging the city's contract, the installed cost to the Homeowner's Association (SWSA) is less than \$125 per tree. These trees are not only a good deal but will leave a great legacy for future residents.

Some residents walking the bike path along Brewster south of Tienken this winter might have noticed there is no longer ice on the bike path. Through the efforts of the Homeowner's Association Board the city was contacted about the unsafe condition and the city installed a culvert to send the water and ice below ground and keep the bike path safe and dry. We are currently in contact with the city to correct the resulting new drainage area in the commons just west of the bike path to properly disperse the water flow and prevent puddling. All work was done at no cost to SWSA.

Unfortunately due to the recent harsh economic conditions, some of the Shadow Woods homes show some signs of neglect. The city of Rochester Hills has a blight ordinance. We have asked the city to have their enforcement officers keep a sharp eye out for violations. The storage or accumulations of junk, trash, rubbish or refuse of any kind is prohibited. If any resident needs to report blight conditions, please call the city at 248-656-4615.

I want to welcome Annella Baker to the Subdivision Board. Annella is taking over Stacey Ferguson's seat on the Board as the chair of the newly re-named Social Committee. Maybe you met Annella at the very successful Easter Egg Hunt she and her committee put on.

Remember that before you invest in any yard or house remodeling or reconstruction, check your Deed Restrictions first! These rules are a legal addendum to your deed, and are incumbent on every Shadow Woods homeowner. Familiarizing yourself with them can definitely save you money and headaches later on! ## Tick Tips for You and Your Family

Someone has reported finding ticks in our subdivision woods. Due to the mild winter and warm spring, it is possible that ticks and other insects may extend into new areas. Here is some information to help you identify and avoid ticks, and to protect yourself from disease.

Ticks are small, dark brown, hard shelled bugs that latch onto a host animal and ingest its blood. Not all ticks are disease-carrying, but some ticks can carry Lyme Disease or Rocky Mountain Spotted Fever. They tend to reside in tall grasses, and under wood and leaf mold.

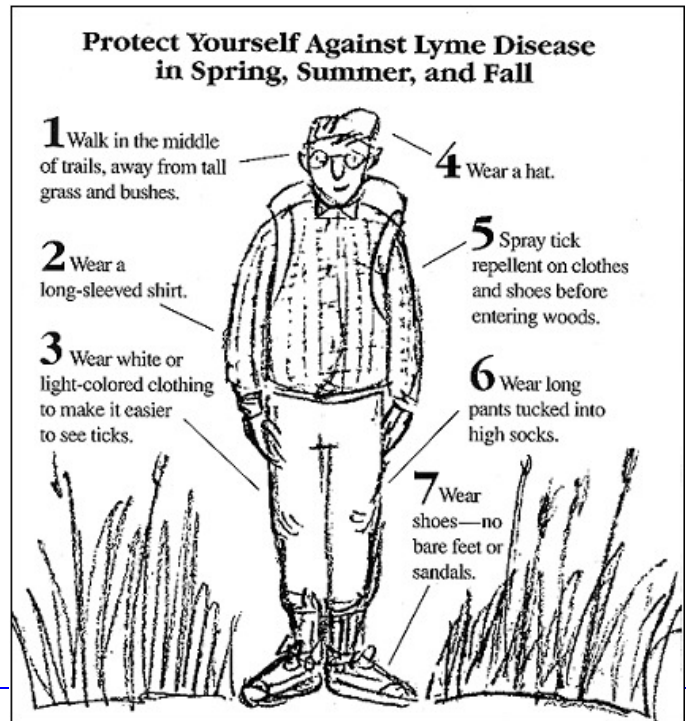
The two most important safeguards against tick-borne disease are

- (1) avoid exposure to ticks
  - (2) find and remove ticks from pets or people
- WITHIN 24 HOURS

When spending time in tick habitat, an insect repellent with 20%-30% DEET is recommended.

Remember, ticks are a natural part of the environment, and while you should take care to avoid and remove them, they should not interfere with your enjoyment of the outdoors.



## Door-to-Door Salesman Safety

Salespeople have the right to solicit business door-to-door in Rochester Hills, so long as they are properly licensed by the City and face basic rules of conduct. In a case where you feel uncomfortable with the behavior of a solicitor who comes to your door, the City of Rochester Hills offers this advice:

The salesperson's permit, or peddler's license, should be clearly visible and available for your inspection.

If a salesperson's behavior makes you feel unsafe or uncomfortable in any way, call the Sheriff at **248-537-3530** and a car will be dispatched as soon as possible. The deputies will check the credentials of the solicitor and advise the City of the complaint. Numerous complaints about the same company can result in having their permit revoked.

Install a "No Solicitors" sign by your door. Salesmen are required to respect the sign.

Remember that you NEVER have to open your door to a stranger.
