Keeping our landfills toxin-free is important for our future. Most people today know better than to toss batteries into the regular trash. But did you also know that you shouldn't put in fluorescent bulbs, aerosol cans, pesticides or *shoe polish*? Meanwhile, we are fortunate to live in a community that offers a safe, reliable way to properly dispose of hazardous household waste. Several drop-off events are sponsored each year. The nearest one for Shadow Woods residents will take place **Sat, June 15, between 8am and 2pm at Oakland University** (parking lot at Walton & Squirrel.)

There is a \$10 fee per car so you may want to partner with a neighbor. To save yourself time, print out an advance registration form by returning to the above web page and clicking on "NO HAZ PROGRAM".

## **Watering Restrictions in Rochester Hills**

Remember to set your automated sprinkler system to run between **midnight and 5am only.** This City ordinance was enacted to move peak water usage to the lowest rate period of the day. In addition, the City is requesting that you set your system to start a few minutes **before or after** the hour. This will help offset a drop in pressure resulting from so many systems kicking on at the same time.

## **Neighborhood Pet Etiquette**

An issue that has been brought to the Board's attention is the number of dog owners who allow their pets to enter other people's property, either running loose or even when being walked. Both City statute and Shadow Woods deed restrictions require owners to have their pets under control at all times, and to not allow them to be a nuisance. Residential lots are not public property. We all know the time and expense it takes to keep our yards looking green and healthy – it is irresponsible to allow our pet to urinate, defecate, or dig on someone else's property.

Residents who do not want a dog on any part of their property at any time should have a way to indicate that. One suggestion is a small sign installed next to the mailbox post. This will convey the message without being unsightly. One possibility:
